#### **Instructions**

- 1. Former/ present Vice-Chancellors of Universities; DG, DDGs, ADGs of ICAR; Secretaries of Scientific Departments of Government of India; Chairman UGC, ASRB, BARC; Principal Scientific Advisors, GOI; Heads of CGIAR Centres; Presidents of Science Academies and Societies; Principals of Colleges; Directors/ Joint Directors of ICAR/ Central or State or Private research institutions; Heads of Institutions of CSIR, ICMR; Deans, Heads of the Departments not below rank of professors can nominate. Nominations can also be made by former TN Ananthakrishnan awardees; NAAS/ INSA/ other National Science Academy Fellows; and by the students of late Prof. TN Ananthakrishnan.
- 2. Nominee should not have crossed 55 years of age for award No. 1 (Senior Scientist Award) and 40 years of age for award No.2 (Young Scientist Award) as on 31 December 2021.
- 3. The award will be made to any Indian citizen for his/ her contributions to Entomology based on the work done in India.
- 4. A 500-word note justifying why the nominee deserves the award is important. Its absence will invalidate the nomination.
- 5. All the required details in the nomination form to be provided on A-4 size white paper.
- 6. Publications of the nominee made in the last 10 years (2012-2021) for award No.1 (Senior Scientist Award) and during the biennium 2020-2021 for award No.2 (Young Scientist Award) in support of nomination should accompany the nomination papers. List research publications in the descending order of NAAS score (NAAS journal ID and NAAS score, as effective 1<sup>st</sup> January 2021). Papers in proof stage/ accepted for publication can be included provided evidence from the journal is submitted.
- 7. An independent jury consisting of eminent entomologists, constituted by the Trustees of the Foundation, will evaluate the nominations and select the awardees. The Juries'/ Foundation's decision will be final.
- 8. There are three awards for award No. 1 (Senior Scientist Award) the first prize carries a cash award of Rs. 25000/-, the second Rs. 15000/- and the third Rs.10000/-. There are three awards for award No.2 (Young Scientist Award)- the first prize carries a cash award of Rs.25000/-, the second Rs.15000/- and the third Rs. 10000/. In addition, a certificate with citation will be given, which will be presented in a simple public ceremony (The date and venue will be notified as and when finalized).

Complete nominations in the specified nomination form with all enclosures must reach Prof. V. V. Ramamurthy (Trustee, The Prof. T. N. Ananthakrishnan Foundation), Ex. Professor, Division of Entomology, Indian Agricultural Research Institute, New Delhi 110012 (mobile no. 9718121160) by email to ananthakrishnanfoundation@gmail.com on or before Thursday, the 31<sup>st</sup> March 2022, 23.59 hrs. As all the nominees tend to crowd the email at the last moment, on 31<sup>st</sup> March only the first come five nominations will be entertained, and the later ones will be ignored.

(max. 50 marks)

- (i) The nominees should submit the list of their 20 best research publications (NAAS rating >6), of relevance to agricultural/ applied entomology/ entomology, in chronological order. For each publication give name(s) of the author(s), indicate the corresponding author by asterisk'\* after his/her name, year of publication, full title, name of the journal, volume No. and page Nos., NAAS journal id, NAAS rating (effective as on 1st January 2021). This format to be strictly followed in a table form.
- (ii) First/ corresponding authors will get full marks (2.5 marks each) and third authorship onwards will get 50% (1.25 marks).
- (iii) One set of reprints of the 20 best research publications listed has to accompany.

#### (b) Publications- Research/ Technical- excl. under (a) above

(max. 15 marks)

Provide complete list of publications -excl. under (a) above; monographs/ revisions, technical bulletins, policy papers, books/ book chapters, proceedings/ abstracts/ papers presented in conferences etc. may be considered. Format for submission same as for (a) above.

### (c) Products and Technologies

(max. 10 marks)

Developer of Products and Technologies authenticated by accredited body at national level

- **Products:** including variety, unique germplasm, genetic stock/ contribution in evolving varieties, chemical/ pathogens/ biochemical formulation, artificial diets/ pheromone formulations, models of institutional innovations, programming, simulation or statistical models and computer software, including extension software such as expert systems and interactive multimedia, new taxa described, new invasives/ new pests/ strains/ biotypes or genetic groups/ entomopathogens/ pollinators/ scavengers identified, new machines/ equipments/ delivery mechanisms or major modifications in them/ development of new value-added products that have been economically evaluated and adopted or have the potential to be adopted on a wide scale. Plant protection/ IPM policy documents, demonstration or popularization of technologies with evidence of coverage can be included here.
- **Technologies:** Research findings that become sustainable practices among the stakeholders. These include innovative/ sustainable IPM, integrated biocontrol/ other resource management, IPM models, remote sensing based models, post-harvest technologies, institutional innovations, innovative extension efforts leading to large scale diffusion and adoption of technologies, farmer or scientist friendly websites/ mobile apps for pests/ natural enemies/ IPM, natural enemies conservation methods/ ecosystem management/ biotechnological or physiological interventions

in IPM, farmers' participatory/ area wide approach technologies, commercialisation of technologies with revenue generation, with evidence of coverage can be included here.

Developer (one) shall be awarded 100% marks, Co-developers (max. two) 50% marks and associates 30% marks.

Patents granted/ commercialized with details of patent no., trademarks and IP protection should be provided (each patent/ copyright scores 2 marks limited to maximum of 5 marks, evidence given must carry the nominees' name). Status of application/ grant to be clearly indicated with dates.

(Max. 05 Marks)

Each project worth >Rs. 5 lakhs as PI/ Project Leader two marks and as CoPI one mark each
